	Many years ago PCSOs were trained in using hand held devices to record the speed of motorists etc, this no longer happens therefore as a neighbourhood team we can't really impact effectively on speeding, but we can support the community via

community speedwatch and the below email outlines the procedure needed to explore the nature of the speeding professionally.

As always myself or my team members are more than happy to join the councillors to have a walk about the location and provide a visible deterrent by our presence but obviously the impact of this is limited to when we are actually there.

E mail regards raising speeding concerns:

Lee has asked me to send you a link to information that may be of interest in relation to road safety and speeding vehicles in your community.

Below is a link to the North Yorkshire speed management protocol, if you have not already done so local councils or residents can formally raise concerns over speeding vehicles in that area, these complaints are then recorded and a speed data logger is deployed over a 7 day period to monitor both traffic volumes and speed. In addition we also review the collision history of the location, once we have all the date back a decision can then be made on the most appropriate outcome for the location.

The outcomes may be:

- 1) No further Action the 85th percentile speeds recorded (speeds that 85% of drivers are travelling at or below) are below the existing speed limit and there is no collision history
- 2) Offer of Community Speed Watch (CSW) more details are found on the link below this is where the 85th percentile fall below enforcement thresholds and there is a minimum collision history or no collision history
- 3) Consideration of Police Enforcement where speeds exceed the 85th percentile and there are concerns of collisions generally this will involve deployment of a safety camera van or bike to the location and at times support from local officers also
- 4) Consideration of road engineering this is where there is a significant collision history which may require rod engineering of some form

The link below does start with information around CSW but at the bottom of the link there is the form to report speeding concerns on-line

Please do come back to me if you require more information or support around road safety and speeding in the village, if you have not already done so in the last 3 years I would certainly recommend submission of speed concern forms from the link above as a starting point".
